



SENIOR REGIONAL SELECTION POLICY 2026

1. OBJECTIVE OF SELECTION POLICY

- 1.1 The over-riding objective of the Senior Selection Policy is to guide selection of regional teams in a fair, equitable and transparent way. Selection for Teams is open to all British Dressage members.
- 1.2 Selection is subject to compliance with British Dressage, BEF and FEI Rules on doping and medication control for Humans and Equines.
- 1.3 The Selection Policy applies to the selection of combinations / teams for the following:
 - **Senior Inter-Regional Competition**
 - **Senior Home Nations Competition**

2. CONDITIONS OF APPLICATION

- 2.1 The Development Officer (DO) is responsible for ensuring that all riders, horses, and ponies available for selection have current full British Dressage membership.
- 2.2 It is the rider's responsibility to ensure that combinations are eligible for selection at their nominated level, according to the rules and schedule at close of entry. Only combinations fulfilling the criteria stated in the Selection Policy will be considered for selection.
- 2.3 Riders applying for consideration for selection MUST ensure their availability for the dates of the respective competition they are applying for. Received applications will deem to be automatic acceptance of the published competition dates.
- 2.4 Selected riders will be required to stable onsite for the duration and must attend the overall prize giving at the end of the competition.
- 2.5 Riders may only represent their region in one category each calendar year (i.e., BD Youth or Seniors). Para riders may go forwards for the Para Home Nations and one other regional team competition in the same calendar year.
- 2.6 Riders who have competed internationally in a CDI-J/YR/U25 in the UK or abroad or a CPEDI3* or above may only compete if a period of 12 months has passed since their last competition at this level.
- 2.7 Riders who have competed small, middle, or big tour at CDI (excluding U25's where applicable) and riders who have represented Great Britain on an Olympic, Paralympic, World or European team (Senior or Para Equestrian) are not eligible to compete.
- 2.8 All competing horses must be a minimum of 5 years old as of 1 January 2026.

3. SENIOR TEAMS ELIGIBILITY

Participating in regional training ensures access to high-quality instruction from fully qualified and insured BD accredited coaches. It also fosters team spirit and the opportunity to form new friendships.

- 3.1 Riders are required to attend **three** BD regional training events in the 12-month period preceding the cut-off date for training and results. BD training events are categorised as activities listed on the regional Horse Monkey booking system, including Flexi training. Attendance at Regional Training in other regions may be included and riders should inform their DO if they have attended training in another region.
- 3.2 Residential camps will be counted as **two** BD regional training events.
- 3.3 **One** non-ridden educational session will count towards eligibility (e.g., Zoom events, veterinary talks, volunteering at a venue, writing / marshalling / scoring etc.) This list is not exhaustive. Events not mentioned may count if agreed with your DO, so please check.
- 3.4 **One** ridden session may be to ride as a demonstration rider at an official BD event.
- 3.5 Riders will be required to provide competition results and details of their training criteria via an online application. All applications must be submitted on or before the cut-off date for team applications.

4. SELECTION CRITERIA

- 4.1 The Selectors reserve the right not to send a team or individual to any competition.
- 4.2 A rider may submit scores from multiple horses or apply with a single horse at multiple levels. However, a team space will be allocated to just ONE combination.
- 4.3 In exceptional circumstances (for example, if the region has too few riders who meet the required eligibility levels), this restriction may be waived, with the approval of the Sport Operations Manager.
- 4.4 **Senior Inter-Regional and Senior Home Nations Requirements:**
 - Attendance at three BD training sessions (as defined above).
 - Four scores achieved at affiliated dressage competitions in the 12 months preceding selection. If coming forward at Prix St George, three scores are acceptable.
 - Minimum of two scores to be within six months of the submission deadline.
 - Minimum of two different judges over the four scores (or three scores at Prix St George).
 - Scores to be achieved at a minimum of two different venues.
 - Only scores achieved at the relevant level/section can be considered (i.e., the level at which the rider is hoping to compete).
 - Freestyle, Quest, Combined Training, virtual online dressage competitions, and HC scores cannot be considered at any level.
 - When using scores from a panel, the overall result must be submitted as it appears on the BD results page.

- Scores achieved at previous Senior Inter Regionals and Senior Home Nations can be used provided that they were achieved in the 12 months preceding selection and can be verified.

5. SELECTION PROCESS

- 5.1 The average score of each combination will be calculated and selection will be based on the highest average scores at each level.
- 5.2 Where different riders' average scores are within 2%, selectors will review each rider's competition record and any other relevant information. Selection decisions will be finalised from the following:
- Consistency and recent form at the level for which the combination is applying
 - Past form at major/team events
 - Results gained in 20 x 60 arena
 - Results gained from a panel of judges
- 5.3 A list of selected combinations and reserves will be published on the regional pages of the BD website and regional social media pages following selection on the publicised team announcement date.

5.4 Selection Dates

Competition scores and regional training being used for selection should be achieved in the 12 months prior to the cut-off date in the table below.

5.5 Eligibility for Classes

- 5.5.1 There is additional information about which horses or riders are eligible to take part in each class. Please see the BD Members Handbook 2026 for general rule number 189 (page 186) and rules 190 / 191 (page 187) for regional team competitions and eligibility.
- 5.5.2 Where exclusions are noted, this applies to the combination of rider and horse. For example, if you have been to the Winter or National Championships (excluding Area Festival), including freestyle, you must compete at the level above the combination competed at.

5.6 Senior Inter-Regional Competition

- 5.6.1 Each Team can comprise of four riders from Preliminary, Novice, Elementary and Medium in either Bronze or Silver sections.
- 5.6.2 Teams may have two riders at the same level and two further riders from two different levels, in accordance with 5.6.1, if fielding a team of three only, each rider must be at a different level.

5.7 Senior Home Nations

- 5.7.1 Each team can comprise of four riders from Preliminary, Novice, Elementary, Medium, Advanced Medium and/or Prix St George. Bronze, Silver, or Gold combinations are eligible.
- 5.7.2 Advanced Medium and Prix St George will be judged as one class for the team results; however, individual placings will be awarded.
- 5.7.3 Each team rider must be at a different level, whether a team of three or four.

6. SELECTION PANEL

- 6.1 All Selectors will be appointed by the British Dressage Regional Committee. They will have the knowledge and experience required to effectively select teams and will be as free from all vested interests / conflicts of interest as is possible. A register of Declarations of Interest will be maintained by the CEO of British Dressage and is available for inspection.
- 6.2 If any member of the Selection Panel would like to be considered for selection, then they must stand down from the Selection Panel for the relevant event and should not take part in any of the selection processes for this event.
- 6.3 If any one of the Selectors has regularly trained any rider who is being considered for selection, they must not take part in the selection decision involving that individual.
- 6.4 The Senior Regional Selection Panel will consist of the following and will be chosen on the basis that they have no conflict of interests:
- Senior Rider Representative
 - Regional Chair
 - One other individual considered to have suitable experience and no conflict of interest.
- 6.5 Final Team selection will be independently verified by a senior representative of British Dressage before the teams are announced and the riders notified.

7. CHANGING REGION

- 7.1 Riders are eligible for regional teams in the region relevant to their home postal address or in another region which the rider has opted to represent.
- 7.2 The rider must inform both the relevant DOs, prior to submitting their team application form, if they elect to represent a region different to their home postal address
- 7.3 A rider may only ride for one region in any calendar year.

8. SUBSTITUTION

- 8.1 The Selectors may substitute a team member for a reserve between the announcement of the Team and up to 5pm the evening before the competition. However, a substitution should only occur in the case of rider health or a veterinary concern.

9. CONFIDENTIALITY

- 9.1 It is vitally important that there is a high degree of confidentiality relating to information which may have a bearing on selection. This applies to all those involved, riders, owners, selectors, and other officials.

10. TEAM SPIRIT

- 10.1 Team spirit is of the utmost importance. British Dressage expects riders, families, and supporters to commit willingly to all aspects of preparation for team competitions as laid down by their region. Riders will be expected to agree and abide by a team code of conduct.
- 10.2 Riders selected to represent their region in the Senior Inter-Regional or the Senior Home Nations will be expected to attend a virtual team information meeting hosted by their region prior to the event.

11. FITNESS

- 11.1 While good results in competitions are important, the onus is on the riders not to over campaign their horses / ponies.
- 11.2 It is important that riders plan, so they and their horse / pony are in the best form for the designated Inter Regional or Home Nations competition.

12. FINANCE

- 12.1 All Inter Regional / Home Nations competitions will be entirely self-funded by riders. Regions may conduct fund-raising activities to assist riders with the funding of attendance at the competition. Details will be available via the DO.

13. CODE OF CONDUCT FOR HORSE WELFARE AND MEMBERS

- 13.1 There must be commitment from all riders to adhere to British Dressage code of conduct for Horse Welfare and for Members, upholding the highest standards at all times. Please refer to the relevant sections in the 2026 BD members' handbook for full details.

14. RULES

- 14.1 All Selected riders agree to always abide by the rules of the competition at all times.

15. POLICY CHANGES

- 15.1 The Training Committee will have the right to amend or change selection policies where necessary at any time in order to fulfil the objectives of the Selection Policy as long as these changes and amendments are clearly communicated to all parties.

16. CANCELLATION / POSTPONEMENT

- 16.1 In the event of cancellation, the relevant parties will be notified straightaway. In the event of postponement, a situation might arise where a new and/or different team

needs to be selected in which case all parties will be notified and normal procedure for selection will be followed.

17. FORCE MAJEURE

- 17.1 In the event of exceptional circumstances beyond British Dressage's control (e.g., disease outbreak in horses or humans, war, or terrorism), the British Dressage Board reserves the right to make the decision either to change the Selection Policy or procedure, which might include withdrawing the Teams from competition or cancelling the competition.

18. VETERINARY / MEDICAL

- 18.1 Selected riders must immediately notify their DO of any change in their own health or fitness status, their equine health status or any veterinary / medical management that is being undertaken.

19. ENQUIRIES

- 19.1 Enquiries about the Selection Policy can be made by contacting the DO in the first instance.

20. OBJECTION PROCESS

- 20.1 The decision of the Selectors is final and binding and not subject to an appeals process.
- 20.2 An athlete may raise an Objection to the Selection Decision, but an Objection may only be made upon the following grounds:
- 20.2.1 That the Selectors have failed to comply with the procedural requirements in this Selection Policy which had a material effect on the Selection Decision, or
- 20.2.2 That the Selectors have made their decision based on a material error of fact, which would have had a material effect on the Selection Decision.
- 20.3 An athlete wishing to object to the Selection Decision should raise their Objection in writing to the BD Chief Executive. Objections must be received within 48 hours of the athlete being notified of the decision.
- 20.4 The Objection must set out the grounds, as detailed in 20.2 above, and include the evidence and any other documentation or information relied upon.
- 20.5 The Chief Executive will review the Objection, in consultation with the Head of Sport. They will either:
- 20.5.1 Refer the decision back to the Selectors,
- 20.5.2 Replace their own decision for the purposes of Selection, or
- 20.5.3 Reject the grounds for the Objection.

- 20.6 The Chief Executive will provide a written decision based on the information provided as soon as is practically possible, and in any event within 48 hours of the Objection. Their decision shall be final, and not subject to any further review or appeal.
